RE: NOFA 2022 HOME Rental Development Grant Funding

Dear Potential HOME Applicants and Administrators,

The Tennessee Housing Development Agency announces availability of approximately \$6 Million for the 2022 HOME Rental Development Round for distribution across Tennessee. THDA will hold a virtual application workshop on January 5, 2023 to help applicants prepare for completing the application, which will open on January 9, 2023 and run through February 24, 2023.

HOME funds for the Rental Development are awarded through a competitive application process to CHDOs, Non-Profit Housing Developers, and Public Housing Authorities. All applicants must be the final owner of the proposed rental housing project and fulfill other eligibility criteria.

An applicant must apply for at least \$300,000. Applicants applying under the HOME Rental Development Matrices may apply for a maximum HOME grant of \$1,500,000.

THDA will hold a virtual application workshop on the dates and times below.
