An Innovative Model

CHI uses initial state investment to leverage federal, local, community, foundational, etc. sources for people living with mental health challenges and co-occurring disorders.

Expanding to New Populations

New recurring state investments totaling \$6.6M have expanded CHI 2.0 to addiction recovery (FY20) and CHI 3.0 reentry populations (FY22).

Creating Homes Initiative



The Creating Homes Initiative was started in 2000 by current Commissioner Marie Williams with support and leadership from then-Commissioner Elizabeth Rukeyser.

Infrastructure & operational costs to establish new housing for people living with substance use disorder, in particular opioid use disorder.


CHI 3.0

Community Supportive Housing

- Permanent supportive housing
- Serves Tennesseans diagnosed with mental illness and cooccurring disorders
- Wrap-around support services include peer recovery support, life skills development, community engagement opportunities, and access to supported employment services.

Supportive Recovery Housing

- Permanent supportive housing
- Array of recovery services to support the substance use, including opioid use, recovery of adults in Tennessee.
- Quality recovery support services include case management, drug testing, recovery skills development, relapse prevention, peer recovery, supported employment, and community engagement.

Supportive Re-entry Housing

- To serve Tennesseans experiencing mental illness and/or substance use disorder who re-enter the community from prisons and jails or have been previously incarcerated.
- Permanent supportive housing
- Quality recovery support services may include recovery & life skills development, recidivism prevention, peer recovery, supported employment, and community engagement.

The Supportive Re-entry Housing program includes housing developed through the Creating Homes Initiative 3.0 (CHI 3.0) grant. New projects are currently under development.



Intensive Long-term Support (ILS)

- Long-term housing with enhanced wrap-around support services
- Community housing opportunities for people discharging from the state's Regional Mental Health Institutes after extended hospitalization stays.
- Individuals served would otherwise not be able to successfully live in the community due to the lack of available housing with the capacity for support to meet their specific needs.

ILS services include psychiatric nursing support, personal care services, training in community living skills, vocational skills, and/or socialization. Two additional ILS sites are currently under development.



Supportive Living

- Licensed Mental Health Supportive Living facilities in 11 counties
- Eligible to apply for \$2.00/day support per eligible individual for up to 30% of eligible residents at each facility.
- Supports the financial viability and, therefore, availability of these housing opportunities for people with a history of mental illness or co-occurring disorders.

Oxford House Housing Program (OHHP)

- Oxford House International, a nonprofit umbrella organization, develops statewide networks of this kind
- Safe, drug-free, supportive housing options for adults in recovery from substance abuse
- Oxford Houses are self-run, self-supported recovery homes
- Oxford House outreach workers seek, identify, and select appropriate rental housing

- Community-based, safe, drug-free housing
- Trained and qualified staff provides included services

Supports Transition to Adulthood
Targets individuals ages 18-25 who transition out of foster care or out of treatment services

"Emerging Adults Housing" Component

Provides safe, quality, and affordable supportive housing with individualized treatment and support services.



"Emerge" Component

A life skills service to increase the development of relevant life skills for functioning in home, school, employment, and community settings.
