## **Notice of Funding Availability; National Housing Trust Fund**

THDA announces availability of \$3,039,651 to award to Public Housing Authorities and Non-Profit Developers to implement eligible affordable rental housing development activities under its **FY2019 National Housing Trust Fund** Program Description approved by the THDA Board of Directors on July 23, 2019. Eligible **rental housing** development activities include the acquisition and/or rehabilitation of units or the new construction of units for rent to extremely low income persons (<30% of area median income). Organizations must be licensed to do business in Tennessee and may serve any community in Tennessee.

## **Eligible Applicants**

Applicants must be a public housing authority or non-profit developer or who will be the owner/general partner of the proposed project. THDA will review organizational letters of existence and licensure to operate in Tennessee as part of the application review process.

#### **Grant Amount**

The maximum National Housing Trust Fund grant is \$900,000. Applicants must apply for a minimum of \$250,000.

#### **Grant Period**

The 2019 National Housing Trust Fund grant period will begin February 1, 2020, and will end January 30, 2023.

# **Application Deadline**

Applications for the 2019 National Housing Trust Fund Grant must be received by THDA on or before 4:00 PM CDT on Thursday, October 3, 2019. THDA anticipates notifying successful applicants by December 15, 2019.
